Williamsport Country Club Membership Application Procedure



1. Membership is open to all persons regardless of race, sex, color, religion, national origin or handicap who are morally, ethically and financially responsible.
2. Proposed membership candidates will be recommended by letters from the proposer and two (2) sponsors setting forth the length of time and nature of their acquaintance with the candidate, the candidate's profession or occupation, the candidate's club memberships, the candidate's references, and such other information that will assist the Membership Committee in acting upon the application.
3. Upon receipt of the letters from the proposer and two (2) sponsors, the Membership Committee may request the proposer and sponsors to meet with the Membership Committee to review the letters received.
4. The Membership Committee will conduct whatever investigation of the candidate it deems prudent and necessary.
5. In proposing a candidate for membership, more than a casual acquaintance with the candidate will be required of the proposer and two (2) sponsors. Both the proposer and sponsors must be prepared to vouch without reservation for the candidate and his family. The proposer will be reminded of the importance of seeing that the candidate (and spouse) is known to some members of the Board of Directors.
6. An application is given to a proposer member. The proposer must complete the application with the candidate. It is then returned for review by the Membership Committee along with a \$500.00 deposit. The deposit is refunded should the application be denied. The deposit is credited towards the Initiation Fee upon acceptance to membership.
7. The Membership Committee makes its report and recommendation to the Board of Directors. After discussion, a vote is taken by secret ballot. If less than two (2) negative ballots are cast, the applicant is preliminarily approved and the application is posted in the Clubhouse. At the next regular meeting after the application has been posted, the Board of Directors will finally approve or disapprove the application.
8. A proposer and sponsors must be voting members in good standing of the Williamsport Country Club.
9. A proposer and sponsors must be members of the Williamsport Country Club for at least two (2) years before proposing or sponsoring a membership candidate.
